Chairman's Report

Highlights attached

- The Council of Social Services was a vision of Norman Kirk and were set up in cities as incorporated societies. Onehunga ODCOSS grew out of the Mayoress's committee but was not an incorporated society and in 1989 when there was no longer a Mayoress the coordinator of the Onehunga Community House assumed the role.
- In 2016 the decision was made to work towards becoming an incorporated society and the first
 paid coordinator Anna Maria de Vos Sanchez was appointed and a Lottery grant was first
 received to pay her salary. ODCOSS became an incorporated society in 2018. During this time
 ODCOSS met on a three- monthly basis, provided speakers, facilitated networking with other
 members and provided professional development on topics including coping with stress
 experienced by social work providers and providing financial advice. Expos were also provided
 and a Rent Smart programme on behalf of the Maungakiekie Tamaki Local Board was
 introduced.
- Ana Maria left in December 2019 for personal reasons and Jenny Tanner was appointed as coordinator. Between April 2020 and March 2021 the committee was greatly affected by the COVID epidemic. Since the lock down ODCOSS has moved to bi- monthly meetings and began another round of the Rent Smart programme.
- An important role of ODCOSS is to advocate on behalf of the community and in 2021 two
 submissions were made on behalf of the community including opposing the closure of Kiwi Bank
 in Onehunga and asking the Maungakiekie Tamaki Local Board to place a stronger emphasis on
 the delivery of social and volunteer services and provide more social support.
- Although ODCOSS is heavily reliant on sponsorship and donations it provides a crucial role to social service groups and their networks and offers support, networking, educational opportunities and community knowledge.
